**Preamble :**

In accordance with the Notification of the Ministry of Environment and Forests under the E.P. Act 1986, the Department of Biotechnology (DBT) had evolved the Regulations and Guidelines on Biosafety of recombinant DNA Research and Bio-containment, 2017 for achieving personnel and environmental safety. Thus, the constitution of the Institutional Biosafety Committee (IBSC) is mandatory in R & D centers at the Institutions/University/Industries/ or any other organization which intends to carry out or engaged in research activities involving genetic manipulation of genetic materials, microorganisms, plants and animals.

In view of this, the University of Mysore, Mysore, in accordance with the DBT guidelines, has decided to constitute Institutional Biosafety Committee (IBSC). Hence, the following order.

Pursuant to the approval of the Hon'ble Vice-Chancellor, University of Mysore, Mysore and permission accorded by the Department of Biotechnology, New Delhi, an Institutional Biosafety Committee (IBSC) consisting the following\* members is constituted in the University of Mysore, for periodically review the biosafety aspects of the research projects involving recombinant DNA technology, genetically modified organisms and other activities related to DNA such as large scale experiments, production, field release and import and export of genetically modified organisms/products thereof for research purpose as per the norms of the DBT guidelines.
