PAPER PRESENTATION

MAJOR THEME:

MAINSTREAMING COOPERATIVES IN THE GLOBAL ECONOMY

The period beginning from the second half of previous decade until now could be considered as a period of economic down turn and uncertainty. What peaked in 2008 as depression has continued to be prevalent as global economic slowdown. "At the present time in the second half of 2012, following five years of financial turbulence the more developed economies of the world remain in a state of crisis from which there is still no apparent exit, and the developing economies are being impeded in their pursuit of the Millennium Development Goals. In many nations, governments are in retreat, cutting their social and public spending, leaving citizens even more vulnerable to economic turmoil. In others, economic power is shifting dramatically with consequential social impacts. A general movement of global power from West to East may be apparent, but there is still little sense of how political institutions are to be reformed to cope with growing social unrest, economic stagnation and future insecurity." Also noteworthy is the fact that amidst the devastating effects that the private sector and even the state sector faced during the period of recession, the cooperatives exhibited tremendous resilience and stability thus drawing greater attention as a form of business enterprise. This situation calls for a relook at the role of cooperatives and exploring the new role the cooperative sector could perform. Given this background the seminar endeavors to explore the ways and means of repositioning cooperatives in the global economic framework.

SUB THEMES

- 1. Impact of cooperatives on other forms of business/economic organizations
- 2. Innovative business practices by cooperatives
- 3. Cooperative, State and Private Sector linkage/collaboration
- 4. Cooperative Governance
- 5. Others. Paper proposals are also welcome on any other area broadly falling under the main themes.

POSTER PRESENTATION

THEME: UNIQUE COOPERATIVES

Researchers are welcome to send proposals for Poster Presentation in the form of case studies on unique cooperatives. The case studies may pertain to any cooperative which could be considered unique on the grounds of its membership composition, nature of business, operational aspects etc. Wall space would be provided to each selected participant and they may use pictures, photos, diagrams and written material as part of poster presentation. Graduate and Research students are encouraged to make use of this opportunity.

ABSTRACTS: Abstracts for papers should be not more than 600 words and should broadly include the research question, related research review, methodology and likely contribution to the filed of knowledge.

Abstracts for the Poster presentation should be not more than 500 words and should explain what is the unique feature of the proposed case study and also the mode of presentation of the poster.

Abstracts received after the last date will not be considered. All abstracts will be peer reviewed and only recommended abstracts would be selected.

All paper/poster presenters will be provided with lunch and midsession tea during the seminar.
