Sub : Designating the Heads of University Institutions and
Post-graduate Dept. etc as Public Information Officers-reg.
Ref : This office Notification No.ET5/330/2005-06 Dated 12-01-2006.

In the Notification mentioned above, the University had designated the Registrar as Public Information Officer and the Vice-Chancellor as First appellate Authority and the Heads of Colleges and Departments etc as Assistant Public Information Officers.

Citizens seeking information under RTI Act used to send their requisitions directly to the Registrar who in turn has to seek the same information from the concerned Depts/Colleges/Institutions, all of which sometime takes more time. In certain occasions, the University has not at all received the information inspite of reminders and in some cases incomplete information is received. For all the delay or lapse on the part of the Heads of different units, it has become exceedingly difficult for the undersigned to answer the objections raised in the second appeal before the Hon'ble State Information Commissioner.

In order to serve the Public within the reasonable time, it has become expedient on the part of the University to designate all the Heads of University Units as Public Information Officers as shown in the enclosed table.
