Theme of the Conference

An international regime is a set of principles, norms, rules and decision-making procedures established by states to guide their behaviour in a particular thematic area. Since then, the international human rights regime has continued to be developed and consolidated as an important component of the global institutional architecture. In practice, international human rights regimes have different levels of institutionality and they have all evolved over time. The scope of human rights is expanding significantly with its effect reaching various hitherto unexplored area of mankind. The history of international concern for human rights and of the attempts to secure those rights on an international basis is a brief one, but it is built on a centuries-old search for human freedom. The international control on State compliance with the individual protection of fundamental freedoms operates also as an effective deterrent at the domestic level. Human Rights treaties by their very nature are substantially different from any other form of conventional international law as States therein do not protect and further their interests, do not seek to establish their rights, but only undertake duties for the benefit of the individual human being.

While the ultimate aim must be the elimination of these dangerous elements from customary international law, it is reasonable to suppose that the growing humaneness of contemporary international law is a welcome development on the horizon. International law is, and must be if it is to fulfill its proper task, a universal system of law. It must not belong to any

particular culture or for that matter any particular ideology. Human rights values derive from and are justified by reference to philosophical constructions of human nature, cultural and religious traditions, and demands from civil society, influence. international In practical importance, the latter two political factors are the most important source of human rights the contemporary Accordingly, despite frequent violations in practice, international consensus implanted human rights as a nearly universal vocabulary of debate, aspiration, and civic challenges to state legitimacy.
