BACKGROUND

India is a multifaceted country with a versatile and complex social order having several languages, culture and religious practices. Though modernity has rubbed off on the masses, yet there are several complicated issues which require a lot of deliberations' to be sorted out. India is considered as a country rich not only because of its natural resources but also as a country with the youngest population. Of course, the population, especially the rural population in India is also considered as the reason for its snarl in economic development, the real cause is the lack of availability of proper skill set in the people. The agenda for inclusive growth was envisaged in the Eleventh Plan document which intended to achieve not only faster growth but a growth process which ensures broad-based improvement in the quality of life of the people, especially the poor, SCs/STs, other backward castes (OBCs), minorities and women and which seeks to provide equality of opportunity to all.

Digital India: the national programme about transforming India, into a digitally empowered society and knowledge economy; was approved by the Cabinet on August 20, 2014. The Digital India programme is a flagship programme of the Government of India with a vision to transform India into a digitally empowered society and knowledge economy. The journey of e-Governance initiatives in India took a broader dimension in mid 90s for wider sectoral applications with emphasis on citizen-centric services. Next, 31 Mission Mode Projects covering various domains were initiated. Despite the successful implementation of many e-Governance projects across the country, e-Governance as a whole has not been able to make the desired impact and fulfill all its objectives.

Make in India (MII): Make in India - the entire country seems like it is being swept away with this new wave of inspiration in the business sector. The "Make in India" program was kicked off in September 2014. It is a national program designed for India to make it into a global manufacturing hub and transforming it into a vibrant economy. The major objective behind the initiative is to focus on the 25 sectors of the economy for job creation and skill enhancement. The mission is to manufacture in India and sell the products worldwide. Some of the key sectors focused upon are: automobiles, chemicals, IT, pharmaceuticals, textiles, ports, aviation, leather, tourism and hospitality, wellness, railways, design manufacturing, renewable energy, mining, bio-technology and electronics.

SUBMISSION OF PAPERS

After the acceptance, presenters must send their full papers (only 7-8 pages). Only 20-25 papers will be accepted for the presentation. **Plagiarized abstract/papers will be summarily rejected.** In case of joint paper both of them must present in the seminar hall during presentation. **No 'in absentia'** certificate please. **Seminar proceedings** will be published with the ISBN and will be issued at the free of cost for the each paper presenter. Engineering college faculties/students are especially encouraged to send papers. Committees' decision in short listing the papers is final and binding. **Please dont bring any paper for the presentation on the day of the seminar.**

LODGING AND BOARDING

Limited number of outstation participants will be provided lodging and boarding facility on **self finance base** in the University guest house (moderately equipped) on twin share basis subject to the availability. It is purely on first come first serve basis and case to case only.

TRAVEL ALLOWANCE:

Limited numbers of out station (beyond 150 km) participants (PG/Ph.D/PDF/JRF/SRF/RA/temporary faculties) will be reimbursed sleeper class train fair by the shortest and the direct route. In the case of Bus only ordinary non AC /non sleeper Govt. bus. They must produce the original 'to and fro' travel tickets for claiming. If you could not produce the 'return ticket' on the spot claim will be rejected. No taxi/auto fair. Those who are from beyond 1500 km a flat rate (fixed) reimbursement may be considered depending on the grants. Temporary faculties must produce a letter in original from the head of the department for claiming TA about their nature of the appointment.
