A PROFILE

Dr.C. Basavaraju, Professor and Dean, Faculty of Law, University of Mysore, Former Registrar, Former Syndicate Member, Ex-Academic Council Member, University of Mysore & Former Registrar (Evaluation) Karnataka State Dr. Ganubai Hanagal Music and Performing Arts University, Mysuru, has come from a poor family of a village in Mysore Taluk. From his student days, he is committed himself for the amelioration for Social cause of the society and has been fighting for the cause of social justice for all in general, weaker and vulnerable section of the society in particular.

Having considered his academic credentials, he has been nominated as MEMBER to the National Assessment and Accreditation Council (Peer Team), Bangalore. By profession, Dr.C. Basavaraju is a law Teacher known for his commitment, honesty, integrity and dedication in his profession. He has made his contribution to the field of law through publishing 74 Research Papers in both National and International Academic journals. He has published 4 books which are more significant for the legal profession and academia. He has presented 86 Research Papers at both National and International Seminars/Conferences. He has carried out research on "Social Justice with Special Reference to Weaker Sections" and Human Rights". His Ph.D thesis has been published in the form of book by the Serials Publications. New Delhi. He has completed one minor and one major research projects funded by the University Grants Commission New Delhi.

Dr.C Basavaraju has made scholarly presentations of his research papers at National & International Seminars/Conferences/Workshops. On invitation, he has visited Jagallonian University, Cracow, Poland and presented his research paper at the International Conference on "Environmental Best Practices in India and Role of the Judiciary".
