## Sub: Inviting Online application of Affiliation for the academic year 2021-22

Colleges affiliated to the University of Mysore may apply in the prescribed proforma seeking renewal of Temporary/Permanent affiliation for the existing Undergraduate and Postgraduate courses in colleges / Permanent Affiliation for existing temporary affiliations / extension of affiliation for courses/ subjects/ languages, and for the grant of additional intake of students and also for Fresh Affiliation for starting new colleges and for starting Postgraduate courses in existing colleges through online portal for the academic year 2021-22.

- Only registered Educational Trusts/Institutions/Organizations should apply for seeking fresh affiliation to start new colleges with a minimum of two courses for the academic year 2021-22.
- 2. The Colleges which are affiliated continuously for a period not less than five years and have fulfilled all the conditions of affiliation and have attained the academic excellence and the administrative standards on an average stipulated from time to time by University and accredited by NAAC with minimum 'C' Grade are eligible to apply for permanent affiliation.
- 3. The Colleges which are continuously affiliated for the last five years and have got four duly qualified core faculty (at least two with Ph.D.) for each Postgraduate programme, and have got proper facilities for Research activities as laid down in the Govt. Order (1) ED 99 UNE 2002 Dated 2.11.2002 (2), ED 107 URC 2006 Dated 21.8.2006, may submit applications seeking fresh affiliation to start Postgraduate programmes during 2021-22. Such desiring colleges shall submit their online applications. In case of MBA/MCA, grant of renewal of affiliation shall be subjected to the conditions that may be laid down by the AICTE / UGC / State Government from time to time.
- Only Registered Educational Trusts/Institutions/Organizations after strictly following the rules/regulations stipulated by NCTE/State Government and University may submit their applications seeking fresh affiliation for starting new B.Ed., B.P.Ed/ B.A.B.Ed/ B.Sc.B.Ed and P.G. courses M.Ed., M.P.Ed., M.Sc.Ed.

- University Grant Commission, State Government and University Guidelines and Regulations pertaining to affiliation issued from time to time should be strictly adhered.
- 6. It is also brought to the notice of the Principals of the existing colleges/registered Trusts/Institutions/Organizations that the application for affiliation shall be submitted only to those courses/optionals which are as per University regulations, and applications that do not follow the University regulations will not be entertained.
- 7. As per the Govt. order, 50% concession in affiliation fee will be given to the colleges run by the SC/ST Managements. Such organizations/Trusts should submit a certificate issued by the competent authority stating that their organization/trust belongs to SC/ST Management. Applications of those who fail to submit such certificates will not be considered for 50% concession.
- Online applications shall be addressed to the Registrar, University of Mysore, Mysore-570005. However, Hard copy of Online applications must be submitted to the Office of the Director, College Development Council, Moulya Bhavan, Bogadi Road, Manasagangothri, Mysore-570 006.

Affiliation fee, Application fee and Service charges if applicable and GST 18% (SGST-9%, CGST-9%) of the Affiliation fee should be paid to the University through separate Demand Draft (D.D.) only in favor of Finance Officer, University of Mysore, Mysore. (Payment made through NEFT or challan will not be accepted under any circumstances)

Registered Trusts, Institutions/Organizations should enclose the following documents along with the application for fresh affiliation.

- 1. Copy of the Registration Certificate of the Education Society.
- 2. Copy of the Memorandum of Articles of Association, Rules, Regulations and Bye-law.
- 3. If it is a Trust, a copy of the Trust Deed and evidence for having registered the same as per rules.
- 4. Latest Audit Report of the Education Society/Trust.
- Audit Report of the College.
- 6. Annual Report of the Previous Year.
- Place in which proposed college is to be located and its suitability (enclose building plan etc.)
- In the case of SC/ST Management, a certificate issued by the competent authority should be enclosed.
- An undertaking in Rs.100/- stamp paper duly certified by the notary should be given as in "Part-C" which is stating that the college will comply with all provisions of the Act, Statutes, Regulations, Ordinance, guidelines issued from time to time etc.
